# **DRAFT**

# A Bill to Prevent the Requirement of Vaccination and Proof of Vaccination, for any Purpose Whatsoever, by any Government, Commercial or Private Entity, and to Prevent any Related Discrimination

Her Majesty, by an act with the advice and consent of the Senate and House of Commons of Canada, enacts as follows:

In view of the fact that even Canada's own Chief Science Advisor has stated that "it has not been directly established yet whether vaccinated individuals become the equivalent of asymptomatic carriers who can continue to infect others." And that there continues to be "uncertainty regarding their (vaccines) efficacy against the different virus strains spread across the globe, among others."

# And, Whereas,

The use of the PCR test, which is still used in Canada to determine COVID cases and which has formed the entire basis of this global pandemic, has now been "pulled off the shelf" by the CDC as it has proved unreliable as a means of detecting a transmittable, infectious virus, and there is mounting proof that the numbers of cases generated by the PCR tests during this pandemic were in many cases up to 97% false positives in countries around the world and here in Canada (depending on the number of cycle thresholds used);<sup>2 3 4</sup>

# And, Whereas,

Studies continue to demonstrate that the vaccines have not proven effective in preventing transmission of infection, and as these injections have only been granted "Interim Authorization" in Canada;<sup>5</sup> <sup>6</sup>

# And, Whereas,

Covid Variants such as DELTA and OMICRON are now occurring as much in fully vaccinated individuals as in unvaccinated individuals: "CDC expects that anyone with Omicron infection can spread the virus to others, even if they are vaccinated;" <sup>7 8 9 10</sup>

It has been determined that over 80% of Covid deaths occurred in the elderly & infirm, who had two or more co-morbidity factors;<sup>11</sup> and that most people have a COVID-19 survival rate of approximately 99.8% with Infection Fatality Rates (IFR) that are comparable to seasonal flus; <sup>12</sup> <sup>13</sup> <sup>14</sup>

#### And, Whereas,

There have been, as of Jan. 14th 2022, over 31,000 total reported deaths, and about 3 million "adverse events," and "adverse reports" reported to VAERS (the US Govt. run Vaccine Adverse Event Reporting System); and over 36,000 deaths and 3 million injuries reported through Eudravigilance (the European Medicines Agency reporting system) through Jan. 1 2022 <sup>15</sup> that have been directly associated with the various COVID injections. VAERS is a passive reporting system, meaning, it is voluntary to report adverse events or deaths. A Harvard Pilgrim Health Care Study <sup>16</sup> concluded that, "Adverse events from vaccines are common but underreported, with less than one percent reported to the Food and Drug Administration (FDA). Low reporting rates preclude or delay the identification of "problem" vaccines, potentially endangering the health of the public." <sup>17</sup>

#### And, Whereas,

There are no long-term non-industry funded studies that examine possible health effects of these injections called vaccines, and as the FDA's own data shows that serious harm such as auto-immune disease, inflammation of the heart and brain, stroke, convulsions, and death can occur after vaccination. The CDC is providing updates but the lack of long-term studies is disturbing when we're doing a mass roll out of COVID-19 vaccines to the population, including our children;

# And, Whereas,

There are many medical treatments other than COVID-19 vaccines, that have proven effective in saving the lives of COVID-19 patients and minimizing the risk of hospitalization such as Ivermectin and Hydroxychloroquine.<sup>20</sup> And in light of the fact that there are many options available that effectively boost people's immune systems naturally and without the kind of risk inherent in these experimental COVID-19 vaccines,<sup>21</sup> <sup>22</sup> and that people's immune systems have evolved over millennia, and most are able to effectively counter viral infections naturally;

#### And, Whereas,

Companies such as Pfizer with the FDA have attempted to hide their vaccine trial data for 75 years indicating that there are serious problems with the vaccine,<sup>23 24</sup> and vaccine manufacturers have been granted total immunity from liability should vaccine injury or death occur after vaccination;<sup>25</sup>

#### And, Whereas,

These vaccines are still in clinical trial stages, meaning they are not fully approved. In Canada the COVID-19 vaccines have "Interim Use" authorization with terms and conditions, in the USA the vaccines have "Emergency Use" authorization;<sup>26</sup> <sup>27</sup>

The Doctors for Covid Ethics in Europe state that "the approval of the COVID-19 vaccines by the EMA was premature and reckless, and that the administration of the vaccines constituted and still does constitute 'human experimentation', which was and still is in violation of the Nuremberg Code." <sup>28</sup>

#### And, Whereas,

Canadians have been forced into taking experimental COVID-19 vaccines in order to keep their jobs, travel, go to school, play sports, go to the gym, theatre or other events, and the Nuremberg Code states that human beings must have "free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision." <sup>29</sup>

# And Whereas,

Canada has heretofore always been considered a free and democratic nation whose Canadian Bill of Rights secures "the right of the individual to life, liberty, security of the person, and the right not to be deprived thereof except by due process of law."<sup>30</sup>

# And, Whereas,

There are currently 20 separate court cases pending in Canada many of which seek to determine whether fraud and deceit have played a role in the management of the COVID pandemic including the use of the PCR test which was used to determine COVID cases and which forms the entire basis of this global pandemic. Many of these court cases are being held up in the judicial system allowing for the continued obliteration of individuals rights and abuses to Canadians;<sup>31</sup>

That there shall be no repercussions on any man, woman or child choosing not to receive a COVID-19 vaccine, injection, therapy, or other medical intervention, or testing, such as forced isolation, forced masking and social distancing, and that taking or receiving tests shall always be by our own choice;

That all personal information such as health information as has been collected on Canadians never be included in any Digital Identity as may be under development in various provinces or even nationally in Canada;

That the use of any form of Digital Identity such as the Bluink apps or others that may be in the works in Canada or elsewhere, always be a choice by the men, women and children who reside in Canada, and that the use of traditional IDs such as Drivers Licenses alway be an option open to all Canadians;

And lastly, that all Vaccine Adverse Event data being collected in Canada immediately be made available for public scrutiny;

Furthermore, all man, woman and child and entities subject to this section are prohibited from subjecting to <u>discrimination</u> any man, woman or child, based on non-receipt of the COVID-19 gene therapy injections, and/or COVID-19 vaccines or any other vaccine, or failure to possess or produce a COVID-19 or related vaccine passport, digital health pass, or other evidence certifying vaccination, immunity, or health status.

#### **CONSTRUCTION & SEVERABILITY**

The provisions of this section shall be construed liberally to accomplish the policies expressed herein.

The provisions of this section are severable.

If any provision of this section or the application thereof is held invalid, the invalidity does not affect other provisions or applications of the section, which remain enforceable.

#### 1. **DEFINITIONS**

- (a) "Governmental entity" means any member or unit of Federal, Provincial, Regional or Local government including, but not limited to, the Premiers of all the provinces, Provincial agencies, the Leaders and members of Governments of Regions, Counties, Cities, Towns, Hamlets, Political Subdivisions, Boards (including School Boards), Departments, Commissions, and special districts and includes all agents, contractors, and employees of any Governmental Entity.
- (b) "Commercial or Corporate Entity" means any corporation, limited liability corporation, non-profit corporation, partnership, limited partnership, limited liability partnership, business trust, joint venture, domestic or foreign sole proprietorship, other domestic or foreign entity or business association, or any other business organization, and includes any subsidiary or parent company of any business organization.
- (c) "<u>Discrimination</u>" the practice of treating a man, woman or child or a particular group in society less fairly than others,
  - A group, human being, <u>Governmental Entity</u> or <u>Commercial or Corporate Entity</u> subjecting any man, woman or child to refusal to hire, failure to promote, reassignment with significantly different responsibilities, reduction in pay, significant change in benefits, employment termination; leave without pay

• Refusal to allow any man, woman and child to enter or patronize a government establishment or an establishment of a <u>Commercial or Corporate Entity</u>, sporting events, activities, education, theatre, etc on the basis of their vaccination or immunity status or failure to prove vaccination or immunity status or because the man, woman and child declined to be vaccinated against COVID-19 for religious, philosophical, medical, or other reason or as a matter of individual medical privacy.

# 2 APPLICABILITY

- a) The Province/Territory of \_\_\_\_\_ and all of its <u>Governmental Entities</u>, <u>Commercial</u> or <u>Corporate Entities</u>, and public private partnerships, may not require or coerce any man, woman and/or child to:
  - Receive the COVID-19 vaccine or any other injection, therapy or drug;
  - Possess a COVID-19 passport, digital health pass, or other evidence certifying vaccination status, testing or health status; and further;
  - <u>Discriminate</u> against any man, woman and/or child based on non-receipt of the COVID-19 vaccine or other injection, therapy, or drug or failure to possess a COVID-19 passport or any other such health pass, digital health pass, or other evidence certifying vaccination, immunity, testing or health status.
- b) The Province/Territory of \_\_\_\_\_ and all of its <u>Governmental Entities</u> may not enter into a contract or give a loan, grant, or any other disbursement of taxpayer money to any <u>Commercial</u> or <u>Corporate Entity</u>, or business affiliation that requires a man, woman or child to receive the COVID-19 vaccine or to possess any kind of health or digital health passport, vaccination passport, or other evidence certifying vaccination, health or immunity status.
- c) Any business affiliation that violates this section materially breaches its contract with the Province/Territory of \_\_\_\_\_\_ or <u>Governmental Entity</u>, rendering the contract voidable by the Province/Territory of \_\_\_\_\_\_ or <u>Governmental Entity</u>.
